Auditors Remarks

- All the departments have done reasonably well in criterion 1 by offering certificate programmes and encouraging field visit/internship.
- While the aided departments have done well in criterion 2, the self financing and BVoc departments have to improve their performance. Few have failed to give even vital data like pass percentages.
- One can understand the absence of any data for projects, publications. But, teachers can be motivated to write text books for their subjects. Similarly, Departments should focus more on extension activities related to their departments. The same activity when extended to more communities will involve all the students. No significant contribution in sports and cultural activities.
- A note on how effectively the departmental libraries is used can be added.
- In criterion 5, student progression data is very important. Also the data on financial help to the students are important. Focus should be on strengthening the Alumni association at department level.
- FDP participation in other institutions should be encouraged by giving grants for travel and registration.
- Best practices should be helping the college in academic and administartion. Hence, the college has to decide two best practices and all the departments should contribute to achieve the objectives of the selected best practices.
- The departments are ranked based on their performance. In general, the aided departments have got the top ranks. The other departments have to interact with these departments on how to present the data and write annual reports in future
